The Need

Since most cancer patients are diagnosed and treated in the community setting, community oncologists play a critical role in the treatment landscape. The community-based clinician must be equipped to see a variety of patients with a wide range of solid tumors and hematologic malignancies as well as manage any treatment-related adverse events. This means that, in a typical day, these clinicians may see a patient with colon cancer, a young patient with non-small cell lung cancer being treated with a targeted therapy experiencing skin rash, as well as diagnosing patients with multiple myeloma, severe anemia, or cytopenia.

These clinicians need resources and guidance from experts on optimal care based on currently available treatment options.

- Community-based oncologists provide care for approximately 80% of cancer patients in the US
 - On average the typical community oncologist treats seven different cancer types on a regular basis
 - Community-based oncologists see nearly double the number of patients daily, compared to their academic colleagues
 - Approximately 20% of rural Americans live >60 miles from a medical oncologist. The geographic distribution of dedicated cancer centers also remains uneven: Almost 14% of Americans (especially rural residents and Native American and Hispanic populations) live >180 minutes from a National Cancer Institute (NCI)-designated cancer center or satellite facility.
 - Patients in Upstate New York and the 150 mile radius fall squarely in the underserved area
